

A NOTE FROM THE DIRECTOR

 \mathbf{V} ou're considering whether or not to apply to be a trustee of Pioneers UK and Ireland (PiUKI).

What might help to inform your decision?

If I were in your shoes, I would appreciate realising that this particular Mission agency has a fire at its heart to serve the church with its God-given mission to make disciples and plant the church of Jesus Christ amongst the nations and its peoples - pioneering particularly to least-reached peoples and unreached places.

We've been doing this since 1881 amongst Arab peoples (as North Africa Mission and Arab World Ministries) ... since 1904 amongst African peoples (as Sudan United Mission and Action Partners) ... and since 2007 amongst unreached peoples and in unreached places from East to West, South to North across the world.

If I were in your shoes, I would definitely value understanding that PiUKI is the name reflecting the merger in 2024 of the two historic UK Mission agencies founded in 1881 and 1904 respectively. With 263 years of combined missions experience, we are, today, at a remarkable moment in our story.

If I were in your shoes, I would want to know that PiUKI is part of a multi-ethnic, multi-lingual, multi-generational, multi-denominational global missions fellowship called Pioneers, founded in 1979 in North America. This international body now has more than 2,500 missionaries serving in Africa, the Americas, Asia, Europe, the Middle East, and Oceania. PiUKI is one of 16 national and continental 'Mobilisation Gateways' within the Pioneers world family.

If I were in your shoes, I would value knowing PiUKI is one of the largest missionary-sending agencies in the UK, with a purpose to exalt Jesus Christ and embrace the nations by enthusing the church in the UK with global mission, by equipping and sending UK Christians of whatever ethnicity to wherever the Lord calls, and by encouraging and supporting missionaries wherever they are in their journey and service. PiUKI presently has 150 field members in nearly 30 countries and a staff team of 37 full and part-time individuals spread across the UK, Ireland and Europe - all with a shared passion to see the church of Jesus Christ planted amongst the yet-unreached.

If I were in your shoes, I would wish to realise that PiUKI sets a high value on partnership – very much including partnership with global south churches and Mission agencies in the mission of God to the nations and peoples of the world.

If I were in your shoes, I would want to know there is a high expectation that the trustees of PiUKI are individuals with a passion also for God's kingdom and mission ... and are those committed to engage in guarding and helping to guide the vision with which we are running.

From the deserts of North Africa to the teeming millions of sub-Saharan Africa, from the vibrancy of Latin America to the rich tapestry of Europe, from the medinas of the Middle East to the crowded cities of Asia, and now to the multi-cultural streets of Britain and Ireland, the vision remains unchanged: to glorify God among unreached peoples and places. Our trustees are part of this sacred and historic vision, a board which helps to guard and guide the going.

As I wrote this, Exodus 23:20f lodged in my spirit and heart.

"See," said the LORD, "I am sending an angel ahead of you to guard you along the way and to bring you to the place I have prepared – my Name is in him." Exodus 23:20f.

Speaking personally, I dare ask the Lord of the harvest to send us trustees who will guard this Mission along the way and who will help bring us to the places and peoples God has prepared beforehand for us. Trustees in whom the Lord has placed his Name.

May the Lord guide you as you decide whether or not to apply!

Core Values

The Heart of Pioneers

Passion for God

The Great Commandment is our motive for the Great Commission. We want to live our lives fully surrendered to Him so that all nations may know that He alone is God.

Unreached Peoples

Pioneers focuses on those with the least opportunity to hear and understand the gospel.

Church Planting Movements

We want to see new believers united in fellowship with other believers, forming churches that plant churches – until all peoples are reached.

The Local Church

Pioneers partners with sending churches to plant new communities of Christians. We also work alongside local, indigenous fellowships wherever possible.

Team-Centred

Teams that are both task- and member-focussed are at the core of Pioneers. This is crucial since many of the world's remaining unreached peoples are in difficult and isolated pockets of the world.

Innovation and Flexibility

Reaching the world's remaining unreached peoples requires creativity and sensitivity to the unique calling, vision, and needs of each missionary.

Participatory Servant Leadership

Pioneers has a decentralised leadership structure. We are principlerather than policy-driven, applying an interactive approach to decision-making that is based on trust.

Ethos of Grace

Understanding that each person bears the image of God, we endeavour to cultivate an atmosphere of mutual acceptance and respect in all our relationships, encouraging one another to attain their full potential in Christ.

Statement of Faith

WE BELIEVE in the one true God who lives eternally in three persons – the Father, the Son and the Holy Spirit.

WE BELIEVE in the love, grace and sovereignty of God in creating, sustaining, ruling, redeeming and judging the world.

WE BELIEVE in the divine inspiration and supreme authority of the Old and New Testament Scriptures, which are the written Word of God – fully trustworthy for faith and conduct.

WE BELIEVE in the dignity of all people, made male and female in God's image to love, be holy and care for creation, yet corrupted by sin, which incurs divine wrath and judgement.

WE BELIEVE in the incarnation of God's eternal Son, the Lord Jesus Christ – born of the virgin Mary; truly divine and truly human, yet without sin.

WE BELIEVE in the atoning sacrifice of Christ on the cross: dying in our place, paying the price of sin and defeating evil, so reconciling us with God.

WE BELIEVE in the bodily resurrection of Christ, the first fruits of our resurrection; his ascension to the Father, and his reign and mediation as the only Saviour of the world.

WE BELIEVE in the justification of sinners solely by the grace of God through faith in Christ.

WE BELIEVE in the ministry of God the Holy Spirit, who leads us to repentance, unites us with Christ through new birth, empowers our discipleship and enables our witness.

WE BELIEVE in the church, the body of Christ both local and universal, the priesthood of all believers — given life by the Spirit and endowed with the Spirit's gifts to worship God and proclaim the gospel, promoting justice and love.

WE BELIEVE in the personal and visible return of Jesus Christ to fulfil the purposes of God, who will raise all people to judgement, bring eternal life to the redeemed and eternal condemnation to the lost, and establish a new heaven and new earth

Guiding Grace Principle

Pioneers is an international fellowship comprised of Christians drawn from many different churches and backgrounds. Our desire is to work in harmony with our national church partners and Christian colleagues on the basis of essential doctrines as found in our Statement of Faith. These are doctrines on which, historically, there has been general agreement among all true followers of Christ.

In matters not addressed by our Statement of Faith, Pioneers acknowledges differing points of view provided they are based on the Bible as the supreme authority, and that no interpretation or practice will undermine the work of the gospel or the unity among those with whom we serve. We seek to live, work, and relate to one another in a spirit of love and humility, as outlined in Romans 14, 1 Corinthians 13, and other passages.

Job Description

Pioneers International Mission Statement

Pioneers mobilises teams to glorify God among unreached people groups by initiating church-planting movements in partnership with local churches.

Main Purpose of the Role

To bring your personal gifting to a team of trustees to provide strategic vision, leadership, governance, oversight and support to the Pioneers UK and Ireland Mobilisation Base, ensuring its activities remain faithful to its stated vision, values and charitable objectives, while complying with relevant laws and regulations.

Key Responsibilities

VISION AND STRATEGY

Participate in setting and reviewing the Mission agency's vision, strategic direction and priorities.

GOVERNANCE AND COMPLIANCE

Participate in ensuring that Pioneers UK and Ireland complies with its governing documents, and those of the wider Pioneers organisation. And ensure that it acts in compliance with UK charity law and all other relevant legislation and regulation.

FAITHFULNESS TO THE CHRISTIAN ETHOS

Uphold and promote the distinctively Christian vision and values of the organisation, integrating faith into strategic decisions and operations.

POLICY AND RISK MANAGEMENT

Review and approve key policies, identify and mitigate significant risks to Pioneers UK and Ireland's effectiveness, reputation and compliance.

ACCOUNTABILITY AND IMPACT

Monitor and evaluate Pioneers UK and Ireland's impact, ensuring effective delivery of its charitable objects and value for its supporters, members and beneficiaries.

AMBASSADORSHIP

Act as an ambassador for Pioneers UK and Ireland and for the wider Pioneers Mission agency, promoting the work, upholding its reputation, and building relationships with supporters, churches, field members and other stakeholders.

Key Responsibilities, continued

SUPPORT AND SUPERVISION

Provide encouragement and accountability for the National Director and staff team, supporting their development and wellbeing.

Prayer and Spiritual Leadership: Maintain prayerful support for Pioneers UK and Ireland and the wider Pioneers family, seeking God's guidance in all decisions and encouraging a culture of spiritual dependency and vitality.

MEETINGS AND PARTICIPATION

Attend and actively contribute to regular Board meetings, sub-committees, and ad hoc key events and contribute adequate time to ongoing Trustee duties.

CONTINUOUS IMPROVEMENT

Participate in Trustee training, self-evaluation and development to enhance the Board's effectiveness.

Time Commitment

The role typically requires in-person attendance at three UK-based Board meetings and three online Board meetings per year, participation in the work of at least one sub-committee, attendance at occasional events, and occasional (and optional) overseas travel on behalf of Pioneers.

Trustees should be willing to devote time to read reports, prepare for meetings, contribute to ongoing Board discussions and undertake other ad hoc tasks.

Terms of Appointment

This is a voluntary position, but reasonable expenses will be reimbursed.

Appointment is usually for a four-year term, renewable by mutual agreement.

Accountability

Trustees are collectively accountable to the Charity Commission and ultimately to the Lord for their stewardship and decision making.

Person Specification

Essential Attributes

A PRACTICING CHRISTIAN

An active member of a local church, with a mature, biblical, understanding of the Christian faith, and a commitment to personal spiritual growth and prayer.

PASSION FOR MISSION

A heart for world mission, evangelism, disciple making and church planting.

INTEGRITY AND WISDOM

Sound judgement, honesty and the ability to act impartially and in the best interests of Pioneers UK and Ireland.

STRATEGIC THINKING

Ability to contribute thoughtfully to strategic discussions, discern priorities and make viable decisions rooted in vision and faith.

TEAMWORK AND COLLABORATION

Willingness to listen, learn and work constructively with fellow trustees, staff and volunteers.

COMMUNICATION SKILLS

Capable of clear, respectful, and effective communication, both in meetings and in representing Pioneers UK and Ireland and the wider Pioneers Mission Agency externally.

COMMITMENT

Willingness to give time, energy and prayer to the role, and to shoulder the responsibilities of charity governance.

Desirable Attributes

PROFESSIONAL EXPERTISE

Skills and experience in one or more of the following: Strategic planning, Finance, Law, Safeguarding, Communications, HR, IT or Project Management.

MINISTRY OR MISSIONS

Experience in ministry, in missions and cross-cultural work, or in Christian charity governance.

GLOBAL PERSPECTIVE

Understanding of and empathy with cross-cultural mission, global church trends, and issues facing Christians worldwide.

Desirable Attributes, continued

RESILIENCE AND ADAPTABILITY

Ability to navigate change, uncertainty, and challenge with faith and perseverance.

ADVOCACY SKILLS

Confidence in speaking publicly, networking, and inspiring others to support the mission agency's work.

Faith Commitment

Trustees are expected to wholeheartedly affirm the Pioneers Statement of Faith (pioneers.org/statement-of-faith) and Pioneers Core Values (pioneers.org/corevalues) and to model Christian character in all aspects of their life and service.

Induction and Training

New Trustees will receive an induction, ongoing training and support from experienced Board members and external providers.

Equal Opportunities

Applications are welcome from all suitably qualified individuals, regardless of age, disability, ethnicity or background.

Safeguarding

Pioneers UK and Ireland is committed to safeguarding and promoting the welfare of all those it serves. All trustees are required to undergo appropriate background checks and adhere to safeguarding policies.

Trustee appointees will be verified against the Charity Commissions published criteria to ensure they are legally qualified to act as a Trustee.
